Excellence in Pursuit of Healthcare Equity**



Organizations are encouraged to submit applications for initiatives that addressed specific disparities in health care processes or patient outcomes, implemented a well-defined intervention, and achieved a measurable, sustained reduction in disparities. **Applications that do not document measurable improvement will not be considered.** Applicants must be United States-based (including US Territories and military bases).

Application period is open February 4 to March 31 at 11:59 p.m. CT.

#### INITIATIVE SPECIFICS

- Name/title of initiative. (limit 250 characters, including spaces)
- Executive summary of initiative. **This section should be written similar to a journal abstract** with a few sentences addressing key concepts related to the project. *(limit 2,500 characters, including spaces; approximately 1 single-spaced page)*
- Describe the healthcare disparity that was the target for the improvement initiative and the importance of this target population to your organization. Articulate the health equity problem/opportunity addressed and its importance. *(limit 2,500 characters, including spaces; approximately 1 single spaced page)*
- Describe how the healthcare disparity was identified at your organization and your baseline measurement of the disparity. **Be sure to provide baseline data.** *(limit 1,250 characters, including spaces; approximately 1/2 single spaced page)*
- Explain what factors you identified as the causes of the disparity and possible targets for your intervention to reduce the disparity. *(limit 2,500 characters, including spaces; approximately 1 single spaced page.)*
- Describe team and stakeholder engagement throughout the initiative. *(limit 1,250 characters, including spaces; approximately 1/2 single spaced page)*
- Describe the intervention(s) and how they were implemented. Specifically, describe the improvement methodology and tools used, strategy adjustments, evidence-based best practices employed, change management strategy. *(limit 2,500 characters, including spaces; approximately 1 single-spaced page)*
- Describe measurable improvement(s) achieved for the targeted disparity. Support this section with data to illustrate improvements in care processes, health outcomes, and/or care experience (i.e., **results tables, statistical tests, run charts, and other quantitative methods**). Initiative achieved results beyond addressing SDOH/HRSN to illustrate improvement in patient outcomes (improved outcomes can include but are not limited to adherence to appointments/follow-up care, decreased morbidity, decreased mortality, improved screening or test results). *(limit 2,500 characters, including spaces; approximately 1 single spaced page)*
- Describe whether the improvements achieved were sustained and any processes implemented to monitor and ensure that the improvement will be sustained in the future. Include the most recent available data. *(limit 2,500 characters, including spaces; approximately 1 single spaced page)*
- Describe how the interventions/solutions were (or could be) replicated by (implemented/disseminated) other parts of your organization or other facilities. *(limit 1,250 characters, including spaces; approximately 1/2 single spaced page)*
- Describe innovative aspects of the work including principles that are applicable to other disparities and/or any lessons learned that may be beneficial to other organizations. Describe the lessons your team learned, and the tools, strategies, and methodologies that other organizations could adapt and adopt to achieve similar results. *(limit 1,250 characters, including spaces; approximately 1/2 single spaced page)*
